Section 2: Noteworthy Incidents

15-19449 6/11/15 Pursuit/ Hit and Run accident

Investigating officers were: Wells/ Burke / Stahl / Letsch

Officer Wells was on Interstate -95, when he observed a grey Mazda traveling in the left lane. The vehicle changed lanes to the center lane and then suddenly cut in front of another vehicle in the left lane, nearly striking the front end of that vehicle in the left lane. He activated his emergency lights.

The grey Mazda then suddenly went across all lanes of traffic and exited at exit 22, trying to elude Officer Wells. The vehicle began traveling at a high rate of speed down the off ramp and then made a turn onto North Benson Road. The vehicle then began traveling at a high rate of speed north on North Benson Road, passing several vehicles on the left as it traveled up North Benson Road. Officer Wells terminated the pursuit due to the reckless operation of the vehicle.

ECC received several more 911 calls reporting the reckless operation of the vehicle. Several callers reported that the vehicle had struck several vehicles after eluding police. The vehicle was last seen traveling north on Church Hill Road.

Officer Stahl's police vehicle is equipped with a license plate reader, picked up the license plate of the Mazda as it passed him at a high rate of speed. The license plate is CT registration 2AR RR3, which is registered to Elsa Flores of 407 First Avenue West Haven CT.

The subsequent investigation in the City of West Haven and positive identification of the vehicle led to an arrest warrant application being filed for the operator residing at 407 First Avenue West Haven CT, for Engaging Police in a Pursuit, Interfering with a Police Officer, Reckless Driving, Evading Responsibility, Evading Responsibility which results in Serious Injury and Reckless Endangerment in the First Degree.

15-20816 /6/22/15/ Missing person/ Suicide

Investigating officers were: Pauciello / Riendeau / Burke / Wells/ Nadeau / Letsch / Chlebowski/ Chamberlin / Sgt. Paris / Sgt .Irizarry

Officers were dispatched to a white van parked on Round Hill Road parked since 0730 hours making it difficult for traffic to pass. Upon arrival Officers found a Ford Transit van, parked on the east side of Round Hill Road facing north. The driver's side window was opened half way, the keys to the vehicle were sitting in the center console. The van's marker plate came back to a residence on Barlow Road.

The subsequent investigation and interview with family members led to a missing person's investigation which included a search of the wooded area adjacent to the parked van. Sgt Paris was made aware of the males missing status and requested a K9 to respond. The missing persons phone was pinged which revealed the last known location being the cell tower on top of Fairfield University's Donnaruma Hall. When a neighboring Police K9 arrived, they began a track which led to the discovery of the missing subject in the wooded area approximately thirty yards east of 1057 Round Hill Road on Fairfield University's property. He was found hanging from a tree limb .He was pronounced dead on scene. This was a great investigative effort for all involved.

15-20879/ 6/23/15 Suspicious Person -Arrest

Investigating officers were: Sudora / Deangelis/ Matajek/ Terifay / Sgt .Paris

Officer Sudora observed a white male subject in the early morning hours standing beside a large SUV on Grasmere Ave. near Longview Ave. As he approached the subject he immediately walked away from the vehicle. The subject then began walking South on Grasmere Ave. in the middle of North bound travel lane. There is a sidewalk beside the North bound lane of Grasmere Ave. He turned his vehicle around and stopped the subject, who was still walking in the roadway and talking on his cell phone. As he approached the subject he observed a knife handle (top) and pocket clip in the right front pocket of the subject. He grabbed the subject by the left arm and he stated that he just smoked dust (angel dust).

Subsequent investigation discovered several vehicles in the area had their doors opened and left ajar. A pat down on the suspect revealed a crack pipe in his front left bottom pocket of his shorts.

A subsequent interview revealed he was in the area to obtain things to pawn, so that he could buy his dust (angel dust).

Suspect was charged with Criminal Attempt to Commit Larceny 6th 53a-49/53a-125b, Possession of Drug Paraphernalia 21a-267a, and Reckless Use of the Highway by a Pedestrian 53-182.

15-21288 6/11/15 SHOPLIFTER / STOLEN VEHICLE

Investigating officers were: Tyler/ Wells / G. Wikman / Sgt. Esposito

Officer Tyler responded to Stop & Shop after Loss Prevention reported they were observing a male wearing a black "doo rag", suspiciously loading items in a cart and he is heading for the exit. The subject got into a red van in the south end of the lot and off duty Officer Gary Wikman pulled into the lot and obtained the plate as CT combination registration 7CT744 with the wording Banton Construction written on the side. The van was listed as stolen from Banton

Construction. After the van fled the lot, Officer Wells began pursuing it westbound on Kings Highway East and then the van turned around eastbound, through traffic construction, where Officer Nadeau saw the driver. The description given was a Hispanic male, with a goatee. The pursuit was called off and subsequent investigation revealed the van was abandoned on Park Avenue at Worth Street in Bridgeport. Banton employees arrived to claim the stolen vehicle. This is incident is currently under investigation

15-21342 /6/26/15 MISSING PERSON / SUICIDE ATTEMPT

Investigating officers were: Chlebowski / Beattie /Nadeau / Renaldi /Matajek

Officers responded to a report of a suicide threat after family members discovered a note left by a family member implying he was going to kill himself. The house was searched thoroughly and he was not found on scene. After gathering information and description of his vehicle Sgt. Paris put out a broadcast to surrounding units to begin searching for him. Officer Beattie located the subject sitting in his vehicle in the parking lot of Veteran's Park. The subject was alert and conscious but unable to communicate clearly. He told officers he ingested alcohol and numerous pills. Subsequent investigation led to AMR and Fire being dispatched and an emergency committal to the Hospital. Officer Beattie's self-initiated search of the area saved the man's life
