# Section 1: Bureau / Division Reports

# **Noteworthy Police Work**

Sgt Irizarry recognized Officer McGrath for his work in locating a subject wanted on a domestic violence related arrest warrant.

Lt. Greene recognized Sgt. Koval, Off. Beattie and Off. Kaesmann for their proactive investigation that resulted in the arrests of three subjects from New York who were passing counterfeit money at Victoria's Secret on Post Road.

Lt. Bloch recognized the following officers for their work investigating a report of 3 subjects attempting to purchase items with a fraudulent credit card. The three subjects identified and arrested. Sgt. Riendeau, Off. Zerella, Off. Kline, Off. Ricco and Officer DeAngelis.

# **Patrol Division**

#### 17-8351/0237 / Narcotics Violation/ Warrant Arrest / Berwick Court

While on routine Patrol Officer Zarella was parked at the end of the cul-de-sac on Berwick Court, when he noticed a black male exit a red colored Hyundai. The Hyundai was parked on the side of road in the area in front of #182 Berwick Court. The male later identified by his NY Driver's License stumbled onto the property and began to urinate. Another passenger exited the car and both met on the property.

On scene investigation revealed that they were all about to get out of the car and go to the Sky Hookah Lounge.

A check of one subject through NCIC/ collect revealed that he had an active hard copy warrant from Troop A Southbury for 21a-279(a) Possession of Narcotics. The warrant was active as of 10-28-16 and it had a court set bond of \$2,500.00. After being placed under arrest, a search incident to arrest yielded (3) individual baggies containing marijuana inside of his hooded sweatshirt. The male was transported to Fairfield Police Headquarters, issued an e ticket for 21a-279a1st Possession of Marijuana under ½ ounce and turned over to Connecticut State Police on the warrant.

#### 17-9279 3:27 AM | Traffic Stop - Arrest | Zerella, M | 00080 Commerce Dr

While on routine patrol an attempt-to-locate hit was received from an LPR on a vehicle wanted by Meriden PD for serial Shoplifters. Off. Zerella stopped the vehicle after it left the Hookah

lounge. He located clothing with tags still attached and the operator possessed approximately \$2,000 in cash. Meriden was PD notified.

#### 17-9272 | 1:46 AM | Narcotics Violation | Chamberlain, R | Carter Henry Dr/Sanford St

Officer Chamberlain checked a vehicle near Crave and found multiple people engaged in Marijuana use.

On scene investigation and an NCIC/ collect check revealed one of the subjects was wanted on a PRAWN warrant for 51-164r. The subject placed under arrest and was released on \$150 bond and an Infraction was issued for 21a-279a1.

#### 17-9394 <u>1:25 AM | M/V Stop/DUI/Weapons | Gorton, T | N Benson Rd/Post Rd</u>

Sgt. Riendeau observed a vehicle swerving in the roadway, then crossing onto the opposite side of the road. A rear window sticker on the vehicle implied there was a gun onboard.

Upon stopping the vehicle Sgt. Riendeau asked where the gun was located. The intoxicated operator pointed out the area within which the illegally-possessed firearm was concealed. The operator was also found to be in possession of suspected Cocaine, pills, and a baseball bat. He was charged with weapons in a M/V and released on \$5,000 bond

#### 17-10880 | 1:48 AM | Attempted Larceny | Kline, J | 00975 E Kings Hwy

ECC received a report that 3 males attempted to buy cigarettes from Cumberland Farms with fraudulent credit cards. Sgt. Riendeau stopped the vehicle as it was leaving. Multiple fraudulent credit cards were discovered, as well as cigarettes likely to be the proceeds of earlier thefts. Additionally, each vehicle occupant was from out of state and has an extensive criminal history

Officers contacted Westport PD to use their credit card magnetic stripe reader for use in determining P/C.

A COLLECT message was sent to state ORI's in order to alert other agencies of the arrests.

All three out of state males were charged with credit card fraud and held on bond.

#### 17-10109 | 4:15 AM | DUI/Interfering | Riendeau, M | 01201 E Kings Hwy

Sgt. Riendeau attempted to initiate a Motor Vehicle Stop after observing a vehicle leaving Sky Hookah accelerate eastbound at a high rate of speed and then accelerate through the red light in the Circle East Traffic circle.

The accused was initially stopped by Sergeant Riendeau on Johnson Drive, then when approached by the officer drove off, and then stopped abruptly at Johnson Drive and Chambers

Street and again when approached by the officer drove off again and was finally boxed in on the I-95 Eastbound entrance ramp by Off. Chamberlain's police vehicle.

The accused then refused to exit the vehicle, or show his hands and wrapped his feet around the steering wheel resisting all efforts to submit to arrest.

Operator was pulled from the vehicle and on scene investigation led to being charged with DUI/ Engaging in pursuit and Interfering with officers.

#### 17-11069 | 4:34 PM | Counterfeit Arrests | Beattie, W | 01499 Post Rd

A concerned employee contacted Officer Beattie stating that several males were inside the store and had just made purchases using counterfeit \$100 bills inside Victoria Secret.

Several officers set up surveillance outside the store and officers detained a subject on foot after leaving the store.

An on scene investigation led to a positive identification of all three subjects by a store employee.

All three men were determined to have purchased merchandise totaling \$1,000.00 with counterfeit bills and were further in possession of \$1,200 in additional counterfeit bills.

All three subjects charged with forgery for the counterfeit bills and Larceny for the theft of merchandise.

ECC received calls after a subjected claimed he was mugged somewhere in Fairfield. He was uncooperative and could not answer questions. On call back stated they were In Westport and were looking for 411, and did not have an emergency

The same caller called 911 back reporting what sounded like a possible accident on I-95 near exit 23. The call was transferred to Troop G

The caller was located at 42 Mill Hill Road and admitted the 911 calls were false. He was charged with making false 911 calls.

#### 17-11691 | 3:42 PM | Counterfeit Currency Arrests | Kaesmann, E | 1499 Post Rd

A concerned employee contacted Officer Beattie for a second time stating that two males were inside the store and had just made purchases using counterfeit \$100 bills.

Officers positioned themselves across the street from the entrance to the store just as a male exited the store carrying a Victoria's Secret shopping bag. Officer Kaesmann exited his patrol

vehicle and made contact with the male and informed him of the reason for stopping him. On scene investigation revealed additional counterfeit bills on his person.

Officer Beattie arrived on scene and made contact with the second male as he exited the store. The on scene investigation led to both subjects being placed under arrest, one subject was found to be in possession of multiple receipts from Victoria Secret in both New York and South Carolina.

A vehicle used to transport the subjects from NY to Fairfield to commit their crime was seized and impounded where additional evidence was found. A total of \$2,200 in counterfeit currency was seized as well as \$1,200 in merchandise.

Both males were charged with Forgery 1, Larceny 6<sup>th</sup> and Conspiracy and released on \$5,000 bond.






Motor Vehicle Accidents - 2017







